

1 BASIC LICENSING SUPPORT

1.1 Overview

The following pages cover basic licensing support.

Network license server (network floating license) and local client machines.

Requires license file and installation of license manager. Clients only require environment variable.

New versions often require the latest version of the license manager.

Local machine (standalone unlimited).

Requires only license file and an environment variable, no license manager installation.

Same license file as from the self-service. Doesn't support remote access.

Dongle (local machine).

Requires license file and dongle. Requires dongle driver installed (only MARINTEK requires installation of license manager).

Marintek supports remote access, but not Sesam/Nauticus products.

1.2 Network license server (network floating license) and local client machines

Requires license file and installation of license manager. Clients only require environment variable.

New versions require the latest version of the license manager. If first time set up, simply **install the latest license manager (on 64 bit machine)**. The license file should typically be put in folder C:\FlexIm. this_host is also a valid hostname.

Install license manager from NH package or Sesam DVD (from top level to include prerequisites), or download separately from: https://sesam.dnv.com/download/programs.html (use sesam if requested for user and password).

If existing installation, then first check version, then upgrade if needed (see above).

If it is not working, send the following from the license server to us:

- C:\Flexlm*.lic files
- C:\Flexlm\dnvs.log file
- Start FlexIm tool (LMTOOLS) and send us output from Server Status and Server Diags tabs. If problem on the client side, send screendump of error in addition to the above.

The client machines require relevant <u>system</u> environment variable pointing to the license server, e.g.:

How to set the system environment variable is described in document: HOW TO SET ENVIRONMENT VARIABLE TO CONNECT TO NETWORK LICENSE SERVER

Note that firewall restrictions may limit the communication between server and client, and exceptions may have to be defined. Details about this can be found in the document: How to check firewall communication?.

Similar is also described in the license manager installation guide.




Example LMTOOLS - lmstat:

1.3 Local machine (standalone unlimited)

Requires only license file and an environment variable, no license manager installation.

Same type of license file as the self-service. No SERVER line. No service running since there is no installation, thus no log file either. this_host is also a valid hostname.

Simply put the file in C:\FlexIm folder and set the system environment variable:

DNVSLM_LICENSE_FILE = C:\Flexlm MARINTEK_LICENSE_FILE = C:\Flexlm

Need to copy or install license manager to run LMTOOLS, but usually all needed info are found in the error message from the application.

1.4 Dongle (local machine)

Requires license file and dongle. Requires dongle driver installed (only MARINTEK requires installation of license manager too).

Other programs don't need installation of license manager. A dongle license is like a standalone license, but locked to the dongle instead of the machine physical address. A dongle may be used on many machines, but only one machine at a time.

Error message about **invalid host** indicates that dongle is **not recognized**. Check that dongle lamp is lit. If not recognized, first try to (re)install the dongle driver from: https://sesam.dnv.com/download/windows64/dongledriver64_111906_inst_w64.zip

Driver should be installed before mounting the dongle the first time (to avoid auto-installation of driver found on Windows update).

May try dongle in different USB port and only remove other dongles.

If still not recognized, try this local link to see if the dongle is recognized:

You may also install FlexIm and use LMTOOLS to check that the dongle is recognized (or not). Dongle driver can also be installed together with FlexIm (check Install dongle driver option during installation) or from vendor site



For **MARINTEK** dongles, check that the license manager is installed and that the service is running (check dnvs.log fil). Dongle must be **mounted before restarting** service or rebooting. Use this_host for server name, e.g. 2002@this_host.

Relevant system environment variables:

DNVSLM_LICENSE_FILE = C:\Flexlm MARINTEK_LICENSE_FILE = 2002@this_host SIMA_LICENSE_FILE = 2002@this_host

Whilst most new program versions (possibly since 2016) has the new common licensing component that supports multiple dongles, programs built with the old licening (auxlib) component only supports one dongle mounted at the time.




- Example dongle license file (standalone unlimited except MARINTEK programs):
